Regional LMC Online Consultation Letter (North Cumbria Only)

Practices may be aware of a draft letter recently circulated by the Chair of the Regional LMC, which has since attracted national attention. The letter has caused concern due to suggestions that LMCs were advising practices to direct patients to attend A&E rather than make use of the Pharmacy First service.

To clarify, this letter was not written, reviewed, seen, or signed by North Cumbria LMC, and therefore was not circulated by us. As North Cumbria is part of our Consortium, the Chair and Executive Lead took the decision not to share this letter with North Cumbria practices, as its content did not reflect our values nor align with how we believe General Practice should engage and collaborate with system partners.

Unfortunately, this document has since been used by NHS England and government representatives to score political points, wrongly linking it to the BMA and GPC. This is both unhelpful and misleading at a time when General Practice faces significant and genuine challenges.

Dr Evans has since stepped down from his role as Chair in recognition of the need for accountability. Although an agreement was reached with NENC ICB by Thursday midday, this outcome has not been accurately reflected in media reports nor publicly acknowledged by NENC ICB.

We do not intend to make any further comment on this matter but felt it was important that practices are aware of our position.
