GP Contract Imposition 2024/25 - Next steps

Nearly 20,000 GPs and GP registrars across the country recently took part in the BMA's GP contract referendum, with 99.2% firmly voting against the 2024/25 GP contract. This is an unequivocal result that will demand NHSE, DHSC, Government, and other parties to sit up and take notice. GPs' views are clear - the contract imposition does not give practices stability and is not safe.

Nationally, GPC England have met to consider the next steps to take as a profession and Lancashire and Cumbria Consortium of LMCs is working closely with them to arrange for roadshows locally. We expect these to take place in June and will keep you updated on the details as they emerge. Please look out for further details on the opportunities that will be provided in the coming weeks and months to engage with this agenda.

NHS Health Checks GP Specification 2024/25 (L&SC)

Lancashire County Council colleagues have recently liaised with the LMC on their health checks specification for 2024/25 and we have provided some robust feedback to their proposals. We expect that changes will be made to in light of this feedback, however, the LMC have not endorsed the revised specification at this time.

A commencement date for delivery to the new specification is yet to be determined, with details soon being made available to practices for your consideration as to how you would look to operationalise it within the funding envelope available. SMS in general practice (L&SC only)

We are aware that L&SC have communicated with practices on the issue of SMS in general practice recently and that the position outlined have caused concern.

Previously, costs for all text messages sent from, or on behalf of, their constituent general practices that have not been funded by other means have been met and this has encompassed all text messages sent from practices. However, in 2024/25 the ICB have been allocated a set budget for this which will be apportioned to practice list sizes. This budget has been increased in recognition of the increased usage of this method of communication with patients etc. and the ICB are continuing to look at other avenues of funding to support general practice.

We want to confirm that the ICB has briefed the LMC whilst reviewing these arrangements and that we have had opportunity to feed into discussions that have informed recommendations to the ICB Commissioning Resource Group. We can assure you that at every opportunity we have raised the concerns we know practices have and queried the potential impact on individual practices throughout. We have also discussed at length the need for extra support and training to practices in utilising their allocated fragments in the most efficient way and will be continuing to liaise with the ICB on this issue to ensure practices are fully supported

Delivery Plan for Recovering Access to Primary Care: new digital explainer on Pharmacy First

General practice teams can <u>now watch an animation</u> developed by Community Pharmacy England explaining the Pharmacy First service, which allows general practice teams to refer patients to pharmacies for minor illness consultations. Pharmacists can now supply prescription-only medicines, if clinically appropriate, for: sinusitis, sore throat, ear infection, insect bites, impetigo, shingles, and UTIs in women (age restrictions apply).
