# **GPCE** Roadshow Update

Colleagues from across the Consortium patch joined LMC members to hear from Dr David Wrigley and Dr Samira Anane at face to face roadshow events in Preston and Carlisle last week. At these sessions, we heard direct from GPC what options are available to practices in terms of collective action and they received feedback on what practices felt this would mean for them and their patients.

In the coming weeks you will hear more from the LMCs in each area as we look to RAG rate the options available within the local context you are working in.

Some practices, we know, have already implemented Safeworking in general practice (bma.org.uk) and there are other initiatives we are working on for you in the short term before collective action commences nationally in the summer.

What was clear from GPC colleagues addressing colleagues locally was there are no steps being suggested that should risk contract breaches or punitive action from CQC, GMC or NHSE Professional Standards teams.

The BMA have also released a Protect your patients, protect your GP practice campaign regarding the GPC England non-statutory ballot which is now open until 29th July, midday. If you are missing your ballot voting email, please visit Ballot voting emails - Contracts - BMA.

#### **RMC Review - GP Survey**

Across Lancashire and South Cumbria (L&SC), there are considerable differences in the way patient choice is offered and how e-RS referrals are processed and managed.

Referral management operating model across the Fylde Coast and Central Lancs is via a Referral Management Centre (RMC) which is delivered by Midlands & Lancashire Commissioning Support Unit (MLCSU). Currently, this supports all practices within these localities in relation to the receipt, processing and booking of referrals.

They would like to hear your views about the NHS e-Referral process that is in operation in your GP Practice, and how the referral is processed within your teams.
