
## **General Practice Alert State (GPAS)**

## Prophylaxis Prescribing - North Cumbria only

We would like to inform practices in North Cumbria that prophylaxis prescribing is now managed exclusively by Cumbria Health, under a Memorandum of Understanding (MoU) with NENC ICB. We would strongly advise practices not to undertake this work as it is unfunded and payment will not be provided for any associated activity.

## **Online Visibility of Serious Diagnosis in the NHS App**

We are aware that of an item in the GP Intranet newsletter titled 'Online visibility of serious diagnosis in the NHS App'. Within this item there was an update from the Cancer Alliance Team reminding practices that in order to prevent incidents where patients view results in the NHS App before they have been informed of their diagnosis, GP surgeries should disable online visibility on the patients' record. This pertains to the online visibility of certain documents that have been sent from Secondary Care relating to new cancer diagnoses.

The LMC does not believe that it is the responsibility of individual GP practices to turn off visibility on some sensitive documents sent from Secondary Care. Secondary Care specialist teams must ensure that the patient has been informed about any relevant diagnosis **PRIOR** to sending clinic letters to the GP Surgery. Once any letters reach the GP practice they will be scanned on to the patient notes. Anything contrary to this would serve to heap further unfunded work pressures onto General Practice. There is also the issue of this being contrary to good clinical practice, where it is expected that it is the responsibility of the investigating clinical team to inform the patient of the outcome of their investigations. We have had numerous instances where upset and tearful patients have presented to the GP to discuss their "new" cancer diagnosis. This is unacceptable.

There are also difficulties with practices turning off visibility temporarily, where they would need to ensure that this is reversed once the patient is informed of their diagnosis, creating a massive administrative burden on practices. There would also need to be appropriate headings on such letters to let the practice know that the patient is unaware of their diagnosis at present.

We are in discussions with the Cancer Alliance team about this matter and will keep you updated.

LAUNCH DATE - Cancer Prehab in Partnership with Football Community Organisations 8 local Football Club Community Organisations have been announced to deliver Cancer Prehab to all cancer patients (18+) preparing for or currently receiving treatment. This includes patients receiving palliative oncology. This service will be self-referral only and initially will be a 1-year pilot, with the clubs looking to sustain the activity after this period. THE GO-LIVE DATE IS WEEK COMMENCING 6TH JANUARY.

Each session will include an hour of personalised exercise, followed by an opportunity to sit down with a brew and a biscuit whilst chatting with other attendees. When possible, the local trusts Macmillan information centre will also be in attendance, to provide advice and support where required.

## Orange Button Scheme - Lancashire & South Cumbria only

Lancashire Mind have released new open-access course dates for Mental Health First Aid and Suicide First Aid (Orange Button approved courses!) -Please see below for more information.

## Orange Button Scheme

The Orange Button Scheme has been running in Lancashire/South Cumbria for about 5 years and it is a way of identifying people that have undertaken suicide prevention training, who now have the confidence to talk to others about suicide. It is a way of showing others in their community who are having thoughts of suicide, or are worried about somebody else, that they are:

- Comfortable to say / hear the word suicide
- Can listen without judgement
- Can inform people where to find help and support

The scheme began on World Suicide Prevention Day 2020 because Lancashire wanted to begin creating a community of Orange Button wearers. A community who want to challenge the stigma around the word suicide. A community that can listen non-judgmentally and be a first step to helping move people towards the information and support they need. It is not a substitute for counselling, mental health support or a crisis service. It is a community scheme made up of members of the public. It is about listening, information giving and signposting.

The training offered by Lancashire Mind is <u>MHFA-Mental Health First Aid</u> and <u>SFA –Suicide First Aid</u>. It is fully funded and available to anyone living or residing in Lancashire/south Cumbria, face to face or online.
